- SSHIX anticipates that the final version will be released in April.

Final OEP Metrics

- SSHIX has submitted our final reports to CMS for the recently-completed Open Enrollment Period.
- CMS' Public Use File (PUF) has not been released yet. However, the following numbers have been approved to share with our Insurance Carriers.
- SSHIX would appreciate your discretion in not publicly promoting these metrics until the official PUF report has been released, which we anticipate within the next few weeks.

Revised Consumer Guidance for Ongoing SEP

- In accordance with the Executive Order issued by President Biden last month, and in response to the ongoing national emergency presented by COVID-19, SSHIX is currently offering a Special Enrollment Period for uninsured Nevadans.
- The SEP began on February 15th and ends on midnight of May 15th.
- The “Missed Open Enrollment” SEP is intended primarily for consumers who did not enroll during the recent Open Enrollment Period. However, consumers who wish to add additional household members to existing coverage can now do so by editing their current application, adding the additional member(s) seeking coverage, submitting the revised application, and then choosing the “Missed Open Enrollment” option when prompted to select their Life Event.

Update on ACA Legislation

- As of 3/8/2021 the COVID Relief Bill is awaiting reconciliation in Conference Committee.
- SSHIX and GetInsured, our technology vendor, have been aware of the pending legislation for many weeks, and we have already begun our analysis of the proposed requirements.
- As the legislation has seen a number of meaningful changes in recent days SSHIX will need to complete our review of the finalized bill text before developing a detailed implementation plan. However, we do anticipate being able to implement key requirements of the legislation between Q2—Q3 of 2021.
- Requirements which are especially complex in terms of policy or technical analysis may take additional time to implement.
- SSHIX hopes to provide a more detailed update on our implementation strategy during the April 13 Monthly Carrier Meeting.
