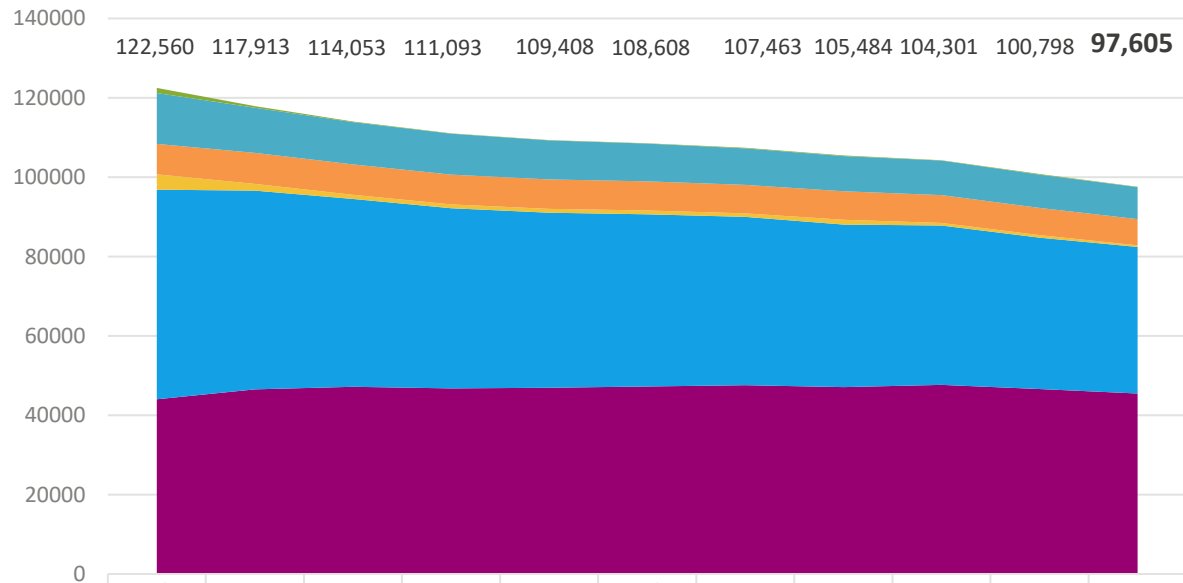

Enrollment Metrics Update

The figures in this table represent Nevada Health Link enrollments in Pending or Confirmed status as of 12/13/2022. Terminated or Cancelled enrollments have been removed from these counts. Please note that consumers who are enrolled in both health and dental plans would be counted twice for each monthly total. A count of unique individuals is provided on the following slide.

Plan year 2022 Health and Dental Enrollments

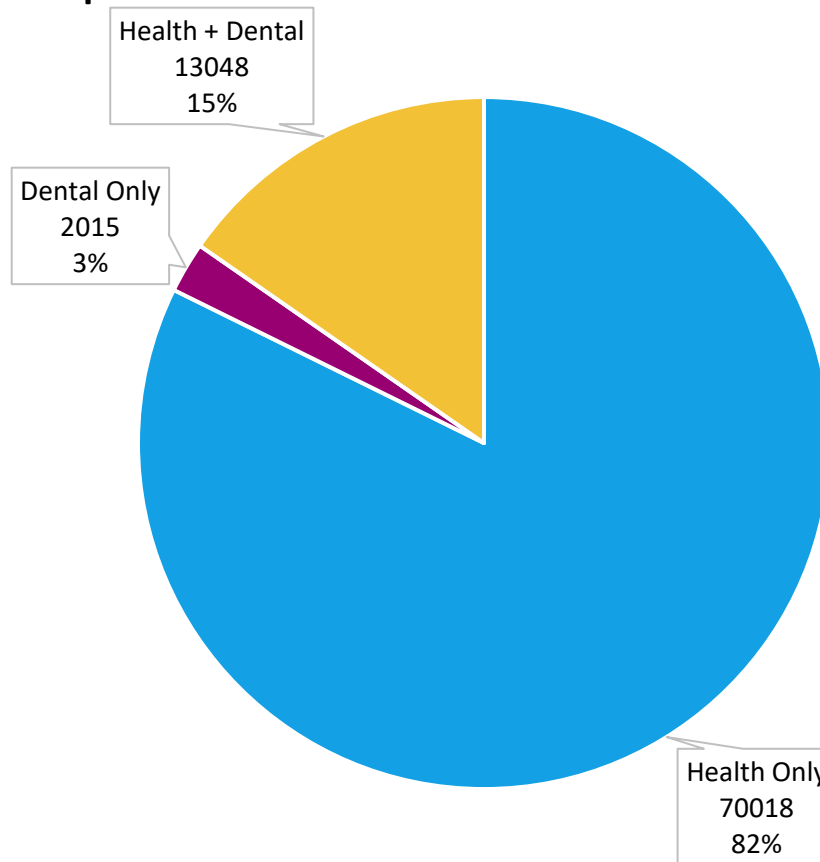

Secondary Auto-Renewals (December Catchup)

- The “Secondary Passive Renewals” or SPR job, which was designed to passively renew 2022 SEP enrollments submitted after the October passive renewals job, ran successfully on Monday, 12/12/2022. The resultant 834 ADD transactions are scheduled to be transmitted in tonight’s batch, Tuesday, 12/13/2022.
- Please note that this job did not passively renew policies which were in a Terminated status during the October passive renewals job but were subsequently reinstated.
- Reports listing the detailed results of this job will be provided by Friday, 12/16/2022.

Eligibility Begin Date Requirements for OEP

- In order to secure a 1/1/2023 Coverage Begin Date, consumers must submit both their application for coverage *and* their 2023 plan selection by midnight on 12/31/2022.
- In order to secure a 2/1/2023 Coverage Begin Date, consumers must submit their application for coverage by midnight on 1/15/2023, and they must submit their 2023 plan selection by midnight on 1/20/2023.
- Under no circumstances will consumers be automatically granted a retroactive Coverage Begin Date by our platform. However, our call center may grant a manual backdate under certain circumstances. Carriers should be prepared to receive ADD transactions for a 1/1/2023 Coverage Begin Date at least through the end of January, 2023.

December RCNI Submission

- The next RCNI Submission Deadline is **Monday, December 19th**. Please note that November submissions should use the new 63-column RCNI format.
- All carriers are expected to submit both a Plan Year 2022 and Plan Year 2023 RCNI in December. 2021 Carriers are also expected to submit a Plan Year 2021 RCNI.
