

Enrollment Metrics Update


The figures in this table represent Plan Year 2023 Nevada Health Link enrollments in Pending or Confirmed status as of 05/01/2023. Terminated or Cancelled enrollments have been removed from these counts. Please note that consumers who are enrolled in both health and dental plans are counted twice in the monthly totals. A count of unique individuals is provided on the following slide.



Enrollees by Insurance Type

The figures in this chart represent unique, Plan Year 2023 Nevada Health Link consumers in Pending or Confirmed status as of 05/01/2023. Consumers enrolled in Terminated policies have been removed from these counts.

Plan Cert Update

- QHP and QDP binder submission is due in SERFF on May 31, 2023. The QHP and QDP Plan Certification Timelines are located in the Plan Year 2024 Final Letter to Issuers, published on the <u>Carrier Resources page</u> of Nevada Health Link.
- CMS QHP Enrollee Survey data submission deadlines for eligible QHP issuers are also included in the QHP Plan Certification Timeline. Please refer to the CMS Marketplace Quality Initiatives website and the QRS/QIS sections of the PY24 Final Letter to Issuers for more information.
- At this point in the PY24 Plan Certification process, it is recommended that Issuers check the Carrier Resources page of Nevada Health Link regularly for updates.

Partnership with Tribal Health Clinics

- 45 CFR 156.1250 requires QHP and SADP issuers to accept payments directly from Indian tribes, tribal organizations, or urban Indian organizations on behalf of their tribal members (this is the same CFR that addresses payments for the Ryan White HIV/AIDS Program).
- Many of our carriers are currently receiving such payments from tribal organizations, however these enrollments are handled on an individual basis, and tribes are lacking an efficient means of managing these enrollments at scale.
- In February of this year the SSHIX Board of Directors approved a streamlined certification process for employees of tribal clinics, or Tribal Exchange Representatives (TERs), which will allow them to use the existing Navigator (or In-Person Assister) user role in our Exchange platform.
- SSHIX's Navigator Program Coordinator will also be working with you to ensure that these individuals are included in your product training sessions going forward.

Partnership w/ Tribal Health Clinics (cont'd)



- In addition to providing direct enrollment assistance to their members, NV's tribal clinics have expressed a great deal of interest in aggregated billing.
- Over the coming weeks, SSHIX will be reaching out to each of your organizations to describe our proposed workflow for aggregated billing and seek feedback and suggestions from your respective teams.
- One of limitations of our platform is that identifying information for navigators cannot be sent via 834, which means that you will not be able distinguish tribal enrollments from non-tribal enrollments using EDI alone.

Partnership w/ Tribal Health Clinics (cont'd)



- To address this limitation SSHIX is currently developing a monthly Tribal Enrollee report, which is based on the existing Monthly Invoices that issuers are currently receiving, but which will be filtered to include only the enrollments that belong to a specific Tribal clinic (one report per clinic).
- As with our Monthly Issuer Invoices, the Tribal Enrollee report will include retroactive adjustments for prior months of coverage.
- SSHIX is proposing that this report be used to facilitate a collaborative review and validation process between issuer and Tribal Clinic, with the goal of calculating a single monthly payment for each tribe's enrollees.

PHE Unwinding Update

- The Nevada Division of Welfare and Supportive Services (DWSS) reported that the first referrals for PHE-related terminations were transmitted to SSHIX in late April.
- The SSHIX call center began making outbound calls to referred households on Monday, May 8th. This effort will continue throughout the duration of the PHE unwinding period.
- SSHIX currently does not have the ability to distinguish between referrals
 that were triggered by the denial of an initial Medicaid application versus
 referrals that were triggered by the termination of an existing Medicaid
 recipient (i.e. PHE-related terminations). However, on Friday May 12th DWSS
 is scheduled to deploy additional data elements to their referral payloads
 which will allow SSHIX to make this distinction.
- In the month of April SSHIX received account transfers for 12,261 households representing 17,727 unique individuals. We estimate that less than 1% of these referrals represented PHE-related terminations. However, we expect this percentage to increase steadily throughout May until the number of termination-related referrals exceeds the number of denial-related referrals.

May RCNI Submission

- The next RCNI Submission Deadline is Monday, May 20.
- All carriers are expected to submit both a Plan Year 2023 RCNI this month. Plan Year 2022 is not required.
