Six Month Look-Ahead

December, 2023

- 12/1: First 30 Days of OEP Press Release
- 12/12: Secondary Passive Renewals (SPR) job; any active 2023 enrollments with no corresponding 2024 enrollment will be passively renewed into 2024 coverage
- 12/25: SSHIX Call Center Closed for Christmas Holiday
- 12/31: Last day to submit enrollment with coverage beginning 1/1/2024

January, 2024

- 1/15: Open Enrollment Ends; Last day to submit OEP Application; SSHIX Call Center will be closed in observation of Martin Luther King, Jr. Day
- 1/16—1/20: SSHIX Call Center will be open with extended hours
- 1/20: Last day to submit enrollment with coverage beginning February 1st, 2024
- 1/22 (-sh): IRS Forms 1095-A will be generated and delivered
- 1/25 (-ish): Post-OEP Press Release

Six Month Look-Ahead (cont'd)

February, 2024

- *Intent to Sell* and *Intent to EDI Test* forms are distributed to Issuers

March, 2024

- *Intent to Sell* and *Intent to EDI Test* forms due in late March

April, 2024

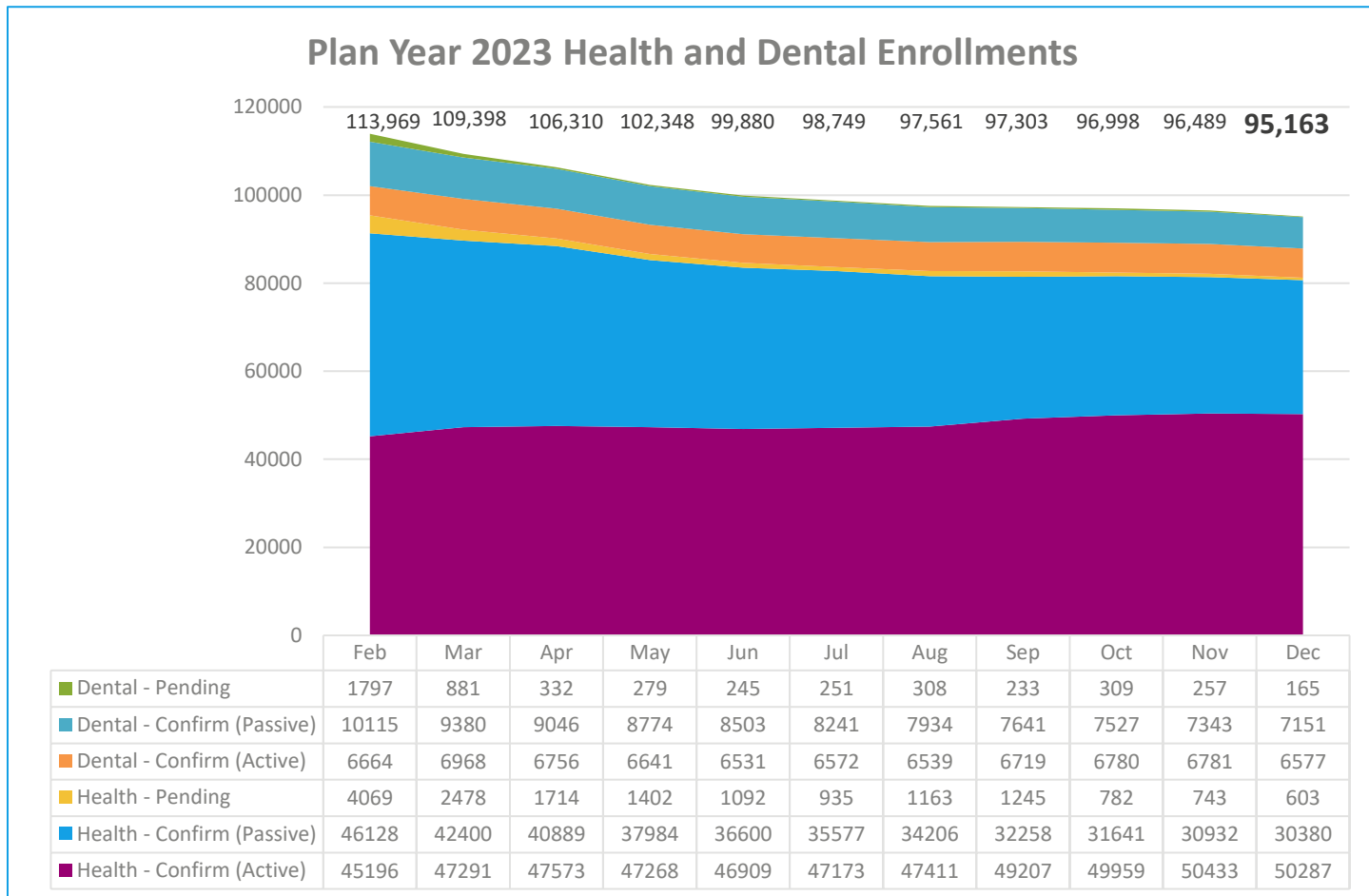
- New Carrier Onboarding begins (schedule TBD)

May, 2024

- Plan Year 2025 Binders prepared for initial Binder Submission deadline in late May/early June.

Health and Dental Enrollments

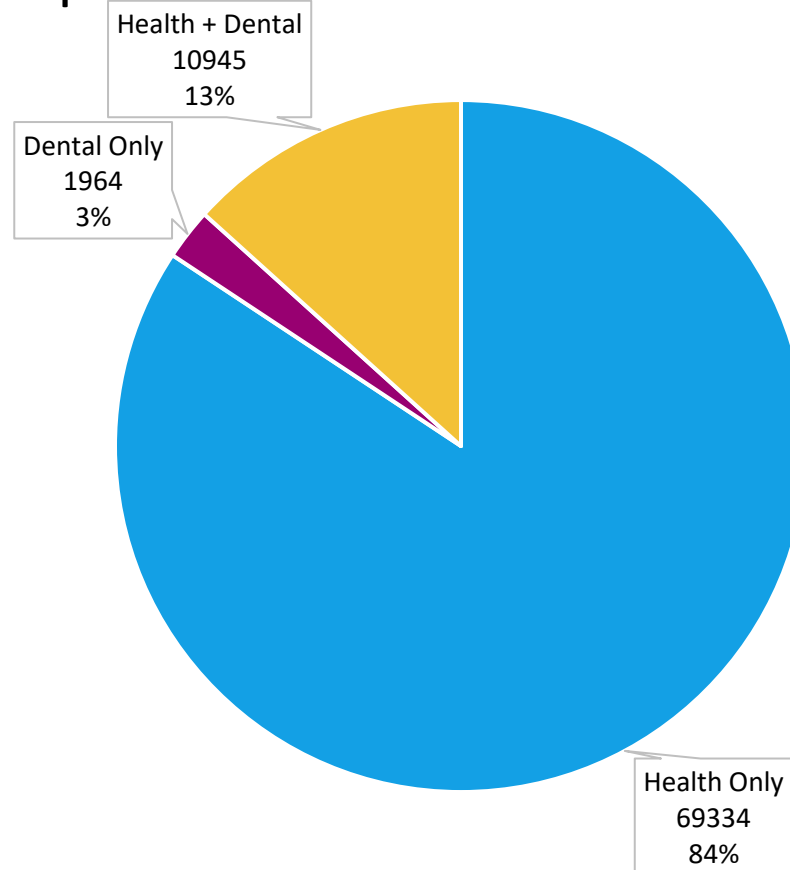
The figures in this table represent Plan Year 2023 Nevada Health Link enrollments in Pending or Confirmed status as of 12/01/2023. Terminated or Cancelled enrollments have been removed from these counts. Please note that consumers who are enrolled in both health and dental plans are counted twice in the monthly totals. A count of unique individuals is provided on the following slide.



Enrollees by Insurance Type

The figures in this chart represent unique, Plan Year 2023 Nevada Health Link consumers in Pending or Confirmed status as of 12/01/2023. Consumers enrolled in Terminated policies have been removed from these counts.

Unique Enrollees for December: **82,234**



Unique Enrollees for November: **83,063**

Open Enrollment Update

- Between 11/1/2023—12/9/2023, SSHIX has processed 23,968 Active Health Plan Selections and 5,291 Active Dental Plan Selections. These figures include both New Enrollees and Active Re-Enrollees.
- As of 12/9/2023, SSHIX is tracking 85,661 unique Health enrollees and 16,242 unique Dental enrollees in Pending or Confirmed status.
- As of 12/9/2023, 96,340 unique individuals have been found eligible for a Plan Year 2024 QHP, of which 82,042 (or 85%) have been found eligible for APTC.

Policy Updates

- SSHIX is currently evaluating proposed changes outlined in the PY25 Draft NBPP. Guidance will be forthcoming.
- At this time, Standardized Plans are not a requirement for SBE's for PY25, although SSHIX is anticipating this may become a requirement in the near future.
- SSHIX does not plan to implement a limit on the number of plans that a single carrier can offer for PY25. Internal review is still ongoing for future plan years.

EDI/Recon Updates

- The Scheduled Passive Renewals (SPR) Job, which is designed to passively renew 2023 enrollments that were not processed by the October Passive Renewals job, is scheduled for Tuesday, December 12th.
- In previous years the SPR job was limited to SEP enrollments submitted after the October renewals job had completed. This year's job will additionally process 2023 enrollments which were in a Terminated status at the time of the October renewals job, but were subsequently reinstated.
- Updated Post-Renewals reports will be distributed following completion of the SPR job.

December RCNI Submission

- The next RCNI Submission Deadline is **Thursday, December 21**.
- Returning carriers are expected to submit RCNIs for Plan Years 2022, 2023, and 2024 this month (please note that this is the final scheduled RCNI submission for Plan Year 2022). New carriers are expected to submit an RCNI for Plan Year 2024.
