# Six Month Look-Ahead

### <u>March, 2024</u>

• Please complete Intent to Sell and Intent to EDI Test forms

### <u>April, 2024</u>

- Intent to Sell and Intent to EDI Test forms due 4/1
- New Carrier Onboarding begins (schedule pending)

### <u>May, 2024</u>

- Prepare Plan Year 2025 Binders for initial SERFF Binder Submission deadline in late May/early June.
- Submit system access forms for Plan Certification personnel who don't have access to NevadaHealthLink.com portal; request *Enrollment Representative (SBE Platform)* role (form is available on <u>Carrier</u> <u>Resources</u> page).



#### March 2024 Enrollment Summary All Enrollees – All Counties



#### March 2024 Enrollment Summary Health Enrollees – All Counties







# **Public Option Update**

- On December 29, 2023, Nevada's DHHS and DHCFP coordinated submission of the Section 1332 "Innovation Waiver" for the Public Option—now called the Nevada Coverage and Market Stabilization Program—to CMS, as mandated by SB 420.
- CMS recently determined the application to be complete and opened a 30-day comment period on February 13. The comment period will conclude on March 14.
- On January 2, 2024, Senator Robin Titus and a non-profit group called the National Taxpayers Union filed a lawsuit seeking declaratory and injunctive relief against the implementation of the Market Stabilization Plan, citing multiple alleged violations of the Nevada Constitution.
- In late February, the Attorney General's Office and the Legislative Counsel Bureau each filed motions to dismiss the lawsuit, and a decision by the court regarding their wish to hear oral argument is not expected until late March.

# **Tribal Sponsorship Update**

The Exchange has met with a number of our carriers over the past several weeks, and the discussions have been very fruitful. We are anxious to meet with the rest of your teams so that we can:

- Learn from the experts in your organizations;
- Seek advice for how we might work with Tribal Health Clinics to improve their PCP claims submissions processes; and
- Answer any new or outstanding questions you might have about our Tribal Sponsorship Program.

# **Plan Certification**

#### **Upcoming due dates:**

- The Intent to Sell form has been sent out and our posted on the Carrier Resources page of the Nevada Health Link website. This is due April 1, 20234
- The Intent to EDI form has been sent out and our posted on the Carrier Resources page of the Nevada Health Link website. This is due April 1, 2024 (Only for new carriers who did not offer plans on the Exchange in PY24)
- The PY25 Draft Letter to Issuers has been sent out and our posted on the Carrier Resources page of the Nevada Health Link website. Public comment is due March 18, 2024.

# **Plan Certification**

### **Common Questions/Issues:**

- While we are in the early stages of planning for PY25, the Nevada Exchange is not considering, at this time, adopting standardized plans, including limiting non-standard plans. Discussions are occurring limiting non-standard plans in the near future based off of plan utilization, enrollment data and guidance in the NBPP.
- Network Providers: This has been a big topic. Please ensure for PY25 the URL template for Network providers is accurate and updated. There have been concerns with the validity of providers being listed that are no longer in network or in contract. If changes are made, directories NEED to be updated in a timely manner.
- Plan Marketing Names: 45 CFR 156.225(c) requires that qualified health plan and plan variation marketing names include correct information, without omission of material fact, and don't include content that is misleading.
- The information must accurately reflect the plan benefits on a plan variant level, including any limitations or cost variations based on provider network or drug formulary tiering, benefit category, or service type.

# **March RCNI Submission**

- The next RCNI Submission Deadline is Thursday, March 21.
- Returning carriers are expected to submit RCNIs for Plan Years 2023 and 2024 this month. New carriers are expected to submit an RCNI for Plan Year 2024 only.
